2. Personal Data We Collect

We may collect and process the following personal data:

- Payment information (processed via third-party providers)
- Technical data (IP address, browser type, cookies)



For minors, parental or legal guardian consent is required.

3. How We Collect Data

We collect data when you:

- Register for training, regattas, charter, or events
- Contact us via website, phone, or messaging platforms
- Subscribe to updates
- Make a payment
- Accept cookies
- Data may be stored in secure email systems, EU-compliant cloud storage, and CRM systems.
- Data is retained only as long as necessary for operational and legal purposes.

4. Legal Basis for Processing

We process personal data based on:

- Performance of a contract
- Legal obligations
- Legitimate business interests
- Explicit consent (marketing and cookies)

5. Payment Processing

Online payments (when enabled) are processed through secure third-party payment providers. We do not store full credit card details.

6. Data Storage and Retention



Personal data may be stored in secure email systems, cloud storage providers compliant with EU regulations, and CRM systems (when activated). Data is retained only as long as necessary for operational and legal purposes.

7. Sharing of Data

We may share data with:

- Insurance providers
- Regatta officials and race committees
- Technical service providers (hosting, CRM, analytics)
- Authorities if required by law

We do not sell personal data.

8. Cookies

Our website uses cookies to improve functionality and user experience. Users may manage cookies through browser settings.

1. General

These Terms govern all services provided by ALPHA SAILING RS LIMITED, including sailing training, regattas, yacht charter, corporate events, fleet management, and professional training programs.

By registering for any service, you agree to these Terms.

2. Participation Requirements

- Minimum age requirements apply depending on the program.
- Participants must be physically fit for sailing activities.
- Mandatory signing of a Participation Waiver before going to sea.
- Parental consent is required for minors.

3. Safety and Compliance

Participants must follow instructor and race officer instructions, wear required safety equipment, and comply with maritime safety regulations. Failure to comply may result in removal without refund.

4. Insurance



The Company maintains appropriate insurance coverage. Participants are responsible for obtaining personal accident and travel insurance where applicable.

5. Liability

5.1 Training with Instructor

If sailing under instructor supervision, operational responsibility remains with the Company.

5.2 Independent Sailing / Charter

For unsupervised sailing or charter:

- A damage checklist is completed before departure.
- Participants are financially responsible for damage occurring during use.
- Liability is limited to actual repair or replacement cost.

6. Weather Conditions

The Company reserves the right to postpone or reschedule sessions due to unsafe weather or safety concerns. Rescheduling will be offered where reasonably possible.

7. Cancellations and Refunds

Cancellation terms may vary by program. General principles:

- Participant cancellations may be subject to notice requirements.
- School cancellations due to safety or weather will be rescheduled where possible.
- No refund for voluntary withdrawal after program commencement.

8. Regattas



Participants agree to follow race rules, accept race committee decisions, respect competitors, and comply with safety protocols. Additional regatta-specific rules may apply.

9. Corporate Events

Corporate bookings require a signed agreement and may require deposit or pre-payment. Damage responsibility agreements apply.

10. Fleet Management and Charter

Separate agreements may apply for long-term fleet use, charter arrangements, and commercial usage.

12. Governing Law

These Terms are governed by the laws of the Republic of Cyprus. Any disputes shall be subject to the exclusive jurisdiction of Cyprus courts.
